### MEMORANDUM

**RE: Updated SC CWP Test & Answer Key, electronic application & finger print submission update, SC IdentGo sites listing, and Mobile Service Requests**

As communicated at the 2018 Summer CWP Instructors seminars, SLED has completed the creation of a “new,” South Carolina Concealed Weapons Permit (CWP) test. A copy of the “new,” test is attached for your use and reference. If you have any questions or need any clarification regarding the updated test, please submit such in writing electronically to [CWPInstructors@sled.sc.gov](mailto:CWPInstructors@sled.sc.gov).

The South Carolina Law Enforcement Division (SLED) implemented a new Concealed Weapon Permit (CWP) system on May 1<sup>st</sup>, 2018. SLED in partnership with *IdentoGo* by *IDEMIA*, have developed the SLED EasyPath system. This streamlined system allows SLED to process CWP’s as required by statute, while offering applicants a new online renewal process, and online replacement feature as well.

In the next phase, SLED will implement a new online CWP registration and electronic fingerprinting capture system that will be available starting January 8<sup>th</sup>, 2019. This phase will allow applicants for a New SC CWP to begin the application online and set up an appointment at an available *IdentoGo* site. At the *IdentoGo* site they can submit their CWP application documentation and have their fingerprints taken and sent directly to SLED electronically for processing. SLED will continue to process all submitted applications received from the *IdentoGo* appointments, those renewals (or replacements) made **online**, and any applications sent by **mail**.

If any of your applicants do not have a means to set up their own appointments at an *IdentoGo* site online or through the SLED webpage, need help rescheduling, or need to cancel an existing appointment they can call the *IdentoGo* by *IDEMIA* customer call center at 866-254-2366.

Please note that we have also included a list of *IdentoGo* host site locations for your future reference. At current *IdentoGo* has (38) host sites up and running and an additional (9) sites that are in the process of being set up (once confirmed I will send a follow-up update).
