ORANGEBURG COUNTY MAN CHARGED WITH MURDER

Agents of the S.C. Law Enforcement Division Wednesday arrested an Orangeburg County man in connection with the September 15, 2019 death of Travion L. Gethers in Santee.

Rayquan Tyrek Rollins, 18, was charged with Murder, Attempted Murder, and Weapons Possession during a violent crime.

The request for the SLED investigation was made by the Santee Police Department.

The case will be prosecuted by the First Circuit Solicitor's Office.
