### **SLED ARRESTS 2 FORMER GOOSE CREEK POLICE OFFICERS IN SEXUAL EXPLOITATION OF A MINOR INVESTIGATION**

Agents from the South Carolina Law Enforcement Division (SLED) charged Conrad Sands Stayton, 40, of Summerville S.C. with Sexual Exploitation of a Minor, Third Degree and Misconduct in Office. SLED agents also charged Shelly Love Ollic, 52, of Saint Stephen S.C. with Misconduct in Office.

Details from the investigation are in the attached warrants.

Stayton and Ollic were booked at the Berkeley County Detention Center.

The case will be prosecuted by the 9<sup>th</sup> Circuit Solicitor's Office.



That between December 2021 and April 2022, while employed as a School Resource Office at the Goose Creek Police Department, assigned to Stratford High School in the city of Goose Creek, County of Berkeley, State of South Carolina, the aforesaid, one Conrad Sands Stayton, did commit the offense of **Third Degree Sexual Exploitation of a Minor**, in violation of Section 16-15-410. The defendant did willfully, unlawfully, and feloniously possess pornographic imagery of a 17-year-old Stratford High School student.

That the defendant did maintain over 15 (fifteen) images of the 17-year-old student engaging in sexual activity or appearing in a state of sexually explicit nudity on his personal cell phone. The defendant had direct knowledge of the student's age and birthdate through his work as an SRO.

That between December 2021 and April 2022, while employed as a School Resource Office at the Goose Creek Police Department, assigned to Stratford High School in the city of Goose Creek, County of Berkeley, State of South Carolina, the aforesaid, one Conrad Sands Stayton, did commit the offense of **Misconduct in Office (Common Law)**. The defendant did willfully, unlawfully, and feloniously fail to properly discharge duties as imposed by law by maintaining possession of pornographic imagery of a 17-year-old Stratford High School student and knowingly permitted the student to continue to produce pornographic imagery of [REDACTED] without taking any documented action to intervene.

That the defendant did maintain over 15 (fifteen) explicit images of the 17-year-old student on his personal cell phone. The defendant also engaged in public displays of affection with the student and failed to document any action(s) taken to stop the minor from engaging in the act of producing obscene material.

The above facts are true and believable based on the defendant's cell phone data obtained through lawful search warrants conducted during the investigation, information provided by witness(s) and statements, and the investigation conducted by the S.C. Law Enforcement Division.




**The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based upon the following facts:**

That between January 2022 and May 2022, while employed as a Lieutenant at the Goose Creek Police Department (GCPD), assigned to oversee School Resource Officers (SROs) in the city of Goose Creek, County of Berkeley, State of South Carolina, the aforesaid, one Shelly Love Ollic, did commit the offense of **Misconduct in Office (Common Law)**. The defendant did willfully, unlawfully, and feloniously fail to properly discharge duties as imposed by law by permitting SRO Conrad Stayton to engage in an inappropriate relationship with a 17-year-old [REDACTED] of Stratford High School.


That the defendant had knowledge of prior allegations against SRO Stayton that involved inappropriate interactions with a juvenile [REDACTED] student in 2018, as verified by documentation related to the allegations. She also had knowledge of a 17-year-old [REDACTED] student spending extended time with Stayton within his hotel room during a GCPD sponsored Explorer program event in January 2022, as confirmed through text messages between the defendant and Stayton on January 16, 2022. No documented action was taken to advise the department, remove Stayton from his position permitting access to [REDACTED] student, and ensure the safety of the students under her care during the event or in the following months. When questioned about the event by SLED, the defendant denied any inappropriate interactions between Stayton and the 17-year-old student. However, prior to that interview, the 17-year-old student had initially reported directly to the defendant that [REDACTED] was sexually assaulted by Stayton, which the defendant in turn immediately reported to GCPD Chief LJ Roscoe.

The above facts are true and believable based on the Stayton's cell phone data obtained through lawful search warrants conducted during the investigation, information provided by witness(s) and statements, and the investigation conducted by the S.C. Law Enforcement Division.
