SLED ARRESTS RETIRED SC HIGHWAY PATROL TROOPER

Today agents with the South Carolina Law Enforcement Division (SLED) charged David Eugene McAlhany, 59, of Greer, SC with:

- Misconduct in Office
- Common Law Misconduct in Office
- Petit Larceny

SLED was requested to investigate by the South Carolina Department of Public Safety. McAlhany was employed as a SC State Trooper at the time of the offense but has since retired. Details from SLED's investigation can be found in the attached warrants.

McAlhany was booked at the Greenville County Detention Center.

The case will be prosecuted by the 13th Circuit Solicitor's Office.
