SLED CHARGES FORMER LEXINGTON COUNTY DEPUTY WITH MALICIOUS INJURY TO PERSONAL PROPERTY, POINTING AND PRESENTING A FIREARM

Today agents with the South Carolina Law Enforcement Division (SLED) charged Kyle Richard Sullivan, 35, of Lexington, SC, with Malicious Injury to Personal Property less than \$2,000, and Pointing and Presenting a Firearm.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On August 10, 2022 at approximately 5:15 p.m. while at the 5500 block of Platt Springs Road, Lexington, SC, which is located in Lexington County, the defendant, Kyle Sullivan, did willfully and maliciously destroy the passenger side window of a 1998 Ford Explorer (SC Tag: EDV176) belonging to the victim, [redacted] by hitting the window with his hand. There was another witness in the area who viewed Sullivan hitting the window causing it to shatter. Both [redacted] and the witness provided statements which were consistent. The damage to the window was less than \$2,000.00
