SLED CHARGES FORMER GREENVILLE COUNTY SHERIFF'S DEPUTY WITH 2 COUNTS OF DISSEMINATING OBSCENE MATERIAL TO A MINOR, 2 COUNTS OF UNLAWFULLY PLACING A CHILD AT RISK

Agents with the South Carolina Law Enforcement Division (SLED) charged Sean Joseph Egan, 27, on Monday, September 11, 2023, with 2 counts of disseminating obscene material to a minor, and 2 counts of unlawfully placing a child at risk.

Egan was booked at the Abbeville County Detention Center.

The case will be prosecuted by the 8th Circuit Solicitor's Office.
