Agents with the South Carolina Law Enforcement Division (SLED) charged Daejon Rashad Jackson, 22, with Murder, Possession of a Firearm During the Commission of a Violent Crime, and Trafficking Fentanyl on Monday, April 1, 2024.

I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

On or about November 14, 2024, at West Williams St. in Sumter County, one Daejon Jackson did commit the offense of murder in that he did kill, with malice aforethought, Frederick Nelson Jr. by shooting him approximately 12 times with a Taurus G2C handgun. After shooting and killing Nelson, Defendant did attempt to conceal the murder by moving Nelson's body to a wooded area in Rembert, SC. Nelson's body was discovered on November 26, 2023 wrapped in bed sheets, a comforter, and a red tarp. The affiant's belief is based upon recorded statements, evidence located outside and inside the residence, telephone records, autopsy results, and SLED forensic laboratory findings. Law enforcement will attest to the same.
