SLED CHARGES TWO FORMER PEE DEE REGIONAL CENTER EMPLOYEES WITH FAILURE TO REPORT ABUSE/NEGLECT AND NEGLECT OF A VULNERABLE ADULT

The South Carolina Law Enforcement Division (SLED) charged Adria Denise Davis, 52, and Tominka Tunisia Grant, 44, with Failure to Report Abuse/Neglect and Neglect of a Vulnerable Adult on Thursday, April 11, 2024.

Davis and Grant were booked at the Florence County Detention Center.

The case will be prosecuted by the 12th Circuit Solicitor's Office.
