SLED CHARGES FORMER LEXINGTON COUNTY SHERIFF'S DEPUTY WITH MULTIPLE COUNTS OF DOMESTIC VIOLENCE

The South Carolina Law Enforcement Division (SLED) charged Joshua D. Jones, 33, with three counts of Domestic Violence, 3rd degree, and two counts of Domestic Violence, 2nd degree, on Monday, June 24, 2024. SLED was requested by the Lexington County Sheriff's Department to investigate.
