I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On August 13, 2022, Christopher Turner did, at Myrtle Beach, within the county of Horry, commit the offense of Domestic Violence Second Degree, to wit: Christopher Turner caused physical harm and injury to the victim, Turner kicked, struck, and pushed to the ground. Turner held down on the floor of their residence with his arm and hands on neck in a manner which would reasonably restrict's breathing and air flow thereby creating a reasonable fear of imminent peril. sustained bruising as a result of the assault.

The Affiant's belief is based upon the victim's statements and a home surveillance recording. This being in violation of Section 16-25-20 (C), South Carolina Code of Laws, 33-24-0076
