SLED CHARGES HORRY COUNTY MAN FOLLOWING OFFICER INVOLVED SHOOTING

The South Carolina Law Enforcement Division (SLED) charged Neil Wade Brown, 60, with the following offenses on Friday, September 13, 2024:

- Burglary, First Degree
- Domestic Violence of a High and Aggravated Nature
- 4 counts of Assault & Battery of a High and Aggravated Nature
- 2 counts of Discharging of a Firearm Into an Occupied Dwelling
- 4 counts of Pointing and/or Presenting a Firearm
- Aggravated Breach of Peace
- 2 counts of Possession of a Weapon During the Commission of a Violent Crime

Details can be found in the attached warrants.

Brown was booked into the J. Reuben Long Detention Center in Horry County.

The SLED investigation was requested by the Horry County Police Department. SLED's investigation is active and ongoing.

The case will be prosecuted by the 15th Circuit Solicitor's Office.

PROBABLE CAUSE:

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On September 12, 2024, at approximately 9:03 p.m., Neil Wade Brown unlawfully entered [REDACTED]'s residence ([REDACTED] South Reindeer Road) in Horry County, South Carolina, after a verbal argument over the telephone with [REDACTED]. As he entered the residence, Brown was armed with a GLOCK 17 9mm handgun (s/n [REDACTED]) and a Hi-Point C9 9mm handgun (s/n [REDACTED]). Brown encountered [REDACTED] and [REDACTED] an argument escalated, and [REDACTED] and [REDACTED] fled [REDACTED] residence towards [REDACTED]'s residence ([REDACTED] South Reindeer Road) next door. Brown pursued [REDACTED] and [REDACTED] while discharging a firearm towards them, striking [REDACTED]'s residence multiple times. [REDACTED] and [REDACTED] entered [REDACTED]'s residence, and Brown discharged his firearm four times into the door of the residence. [REDACTED] and [REDACTED] each sustained a gunshot wound requiring extensive emergency medical treatment. Brown returned to the [REDACTED]'s residence and barricaded himself inside. While inside, Brown discharged his firearm multiple times, causing extensive damage to the residence. Two fired projectiles entered the bedroom of the [REDACTED] residence ([REDACTED] South Reindeer Road), while it was occupied by [REDACTED] and [REDACTED]. Due to Brown discharging firearms recklessly, with no regard for the safety of the nearby innocent citizens, Horry County Police Department (HCPD) evacuated many residences in the community, causing mass mayhem. At approximately 9:51 p.m., Brown was confronted by HCPD [REDACTED] and HCPD [REDACTED] while Brown was standing in [REDACTED]'s backyard, brandishing his firearms. Officers challenged Brown, and Brown discharged his firearm multiple times in the direction of the officers. In return, HCPD officers discharged their department-issued firearms; however, no one was injured during the exchange. At approximately 11:08 p.m., Brown surrendered to HCPD. This Affiant's belief is supported by audio/video surveillance recordings, witness/victim statements, physical evidence collected from the scene, and post-Miranda admissions by Brown.
