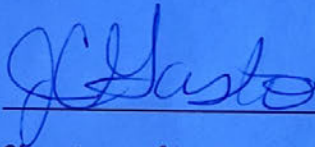

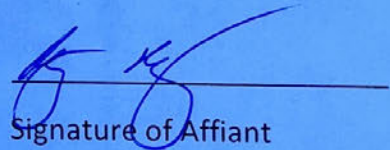
ARREST WARRANT

2024A2010100443

From May 2022 through July 2023, the GRCDC received \$100,000 in state funded grants to begin the construction of a community center in Fairfield County. The offense occurred between May 19, 2023 and February 29, 2024. President withdrew approximately \$44,220 from the GRCDC bank account without the approval or knowledge of GRCDC board members. When questioned by members of the GRCDC board, President admitted to withdrawing the money and agreed to pay the money back. President began making payments back for the funds fraudulently withdrawn in June 2024. After a review of financial records, President used the withdrawn funds for his personal enrichment. This being in violation of 16-13-230 (A)(B)(3) of the South Carolina Code of Laws as amended.
