SLED CHARGES FORMER CUSTODY OFFICER WITH NEGLECT OF A VULNERABLE ADULT AND MALICIOUS INJURY TO PERSONAL PROPERTY

The South Carolina Law Enforcement Division (SLED) charged Brandon Oneil Stewart, 38, with Neglect of a Vulnerable Adult and Malicious Injury to Personal Property on Monday, December 23, 2024.

Stewart was booked into the Alvin S. Glenn Detention Center in Richland County.

The case will be prosecuted by the 5th Circuit Solicitor's Office.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about 07/16/2024 while working as a Custody Officer, for Wellpath Recovery Solutions, at 4546 Broad River Road, Columbia, SC in the Dutch Fork Magistrate District of Richland County it is believed that one Brandon Stewart did commit the crime of Neglect / Neglect of vulnerable adult. The defendant did destroy the victim's food tray by throwing it on the floor, stepping on it, then throwing the food items at a door. The defendant also destroyed the victim's replacement meal by throwing it on the floor and then into the trash. The defendant's actions resulted in the neglect of the victim by depriving the victim of his meal. The victim, is a resident at Wellpath Recovery Solutions and is a vulnerable adult. These allegations were corroborated through interviews, surveillance videos, and information provided to the South Carolina Law Enforcement Division. All against the law, peace, and dignity of the State of South Carolina. CS #2024-00470.
