SLED CHARGES BERKELEY COUNTY MAN WITH INSURANCE FRAUD

The South Carolina Law Enforcement Division (SLED) charged Jonathan Terraine Reid-Boyd, 25, with Presenting a False Claim for Insurance Payment – value \$10,000 or more, and Forgery – value \$10,000 or more on June 4, 2025. The South Carolina Department of Insurance requested the SLED investigation.

Reid-Boyd was booked into the Berkeley County Detention Center.

The case will be prosecuted by the South Carolina Department of Insurance.

On or about September 15, 2023, in Berkeley County, South Carolina, the defendant, Jonathan Terraine Reid-Boyd, knowingly submitted a false claim for insurance payment to Progressive Insurance Company. Reid-Boyd submitted fictitious medical documents for services he did not receive, as well as altered a legitimate document by substantially inflating the cost for medical services that were billed in an attempt to gain an undeserved economic advantage. These documents were confirmed by the medical provider, Roper Radiologists, to not reflect their billed amounts. In total, Reid-Boyd attempted to collect \$43,473.17. This affiant presents these facts based on provided claim information, electronic communication records, and information obtained by the billing provider.
