SLED CHARGES THREE PEOPLE IN RICHLAND COUNTY FOLLOWING DOG FIGHTING INVESTIGATION

The South Carolina Law Enforcement Division (SLED) charged Markus Anjawn Brown, 47, with Criminal Conspiracy and Animal Fighting on Thursday, June 12, 2025. On Friday, June 13, 2025, Brown was charged with seven counts of Ill Treatment of Animals and seven counts of Animal Fighting.

SLED also charged Lucille Oree, 69, with Criminal Conspiracy and Ill Treatment of Animals, and Kionna Rakayla Grant, 27, with Criminal Conspiracy, seven counts of Ill Treatment of Animals, and seven counts of Animal Fighting on Thursday, June 12, 2025.

A total of 23 dogs, including six puppies, were seized on Thursday from two Richland County residences. SLED's Dog Fighting Unit was assisted by the Richland County Sheriff's Department and the Humane World for Animals.

Details can be found in the attached warrants.

Brown was booked into the Sumter-Lee Regional Detention Center in Sumter County.

Oree and Grant were booked into the Alvin S. Glenn Detention Center in Richland County.

The case will be prosecuted by the 5th Circuit Solicitor's Office.

On June 12, 2025, one Markus BROWN, did unlawfully possess a quantity of cocaine base, a controlled substance that weighed more than 1 gram but less than 10 grams. This violation taking place at 4013 W. Beltline Blvd., Columbia, in Richland County, South Carolina. This being in violation of Section 44-53-0375(B)(1) South Carolina Code of Laws, 1976, as amended. Affiant knows this to be true because law enforcement executed an arrest warrant on BROWN at 4013 W. Beltline Blvd., Columbia. BROWN had in his possession at the time of the arrest, a quantity of suspected cocaine base, with an approximate field weight of 7.1g, and a quantity of suspected Marijuana, with an approximate field weight of 11.8g. Agents conducted a positive presumptive test of cocaine base, possessed by BROWN, utilizing a Thermo Scientific TruNarc device. All narcotics located on BROWN's person were submitted to the SLED Laboratory for further testing. This incident is further supported by SLED case number
