SLED CHARGES RICHLAND COUNTY WOMAN WITH CRIMINAL CONSPIRACY

The South Carolina Law Enforcement Division (SLED) charged Ffrancine Dianne Henry, 30, with Criminal Conspiracy on Tuesday, June 24, 2025. The co-defendant mentioned in the warrant, Arias Armaine Johnson, was arrested on June 6, 2025, for purchasing vehicles from dealerships online using a stolen identity.

Details can be found in the attached warrant.

Henry was booked into the Alvin S. Glenn Detention Center in Richland County.

The case will be prosecuted by the 5th Circuit Solicitor's Office.

I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

That on or about June 6, 2025, while at 6892 Garners Ferry Rd., in the County of Richland, one Ffrancine Dianne Henry did commit the crime of criminal conspiracy, in that she and Arias Armaine Johnson, devised a scheme to purchase vehicles using stolen identities and have the vehicles delivered to various locations in SC and NC where Johnson or Henry would take possession of the vehicles. S/A Ludwig was contacted by [REDACTED] with regards to Johnson attempting to purchase a 2024 GMC Sierra Denali 2500 using a stolen identity. Johnson and Henry arrived on scene in a 2024 Audi Q5, which was discovered to be purchased using stolen identity. Johnson had the key in his possession at the time of arrest. Henry was stopped while driving the vehicle away from the scene. Affiant's belief is based upon SLED investigation 2025-03498 Affiant and others are witness to prove same.
