The South Carolina Law Enforcement Division (SLED) charged Reaj Islam, 52, with the Computer Crime Act - Value Exceeds \$10,000 - 1<sup>st</sup> Degree on Thursday, September 11, 2025. Spartanburg Community College requested the SLED investigation.
