SLED CHARGES ANDERSON COUNTY MAN WITH LOTTERY FRAUD

The South Carolina Law Enforcement Division (SLED) charged Dajun Marquis Martin, 33, with Intent to Defraud, Counterfeit Game Tickets and Attempting to Influence a Game by Tampering on Saturday, December 6, 2025. The SLED investigation was requested by the South Carolina Education Lottery.

Martin was booked into the Anderson County Detention Center.

The case will be prosecuted by the 10th Circuit Solicitor's Office.

That on July 7, 2025, the defendant, Dajun M. Marin, did with intent to defraud, unlawfully pass a quantity of stolen South Carolina Education lottery (SCEL) scratch off tickets at Stop A Minit store # 8, located 4154 Clemson Blvd., Anderson (Anderson County), SC, 29621. The tickets were previously stolen by the defendant from the Raceway Gas Station, located at 4606 Clemson Blvd., Anderson, (Anderson County), SC, 29621. Surveillance footage confirms the defendant scanned the tickets at the Stop A Minit Store #8 lottery terminal and then presented the tickets to the clerk for winnings. The defendant was positively identified by local law enforcement. The affiant and others are witness to prove the same. Probable cause based upon police investigation.
