SLED CHARGES FORMER HORRY COUNTY POLICE OFFICER WITH BRIBERY BY A PUBLIC OFFICIAL AND MISCONDUCT IN OFFICE

The South Carolina Law Enforcement Division (SLED) charged Aldrich Roshun Calloway, 35, with two counts of Bribery by a Public Official, and two counts of Misconduct in Office on Friday, April 10, 2026.

Details can be found in the attached warrants.

Calloway was booked into the J. Reuben Long Detention Center in Horry County.

The case will be prosecuted by the 15th Circuit Solicitor's Office.

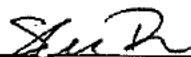

On April 2, 2026, [REDACTED] placed a recorded call to PFC Calloway and PFC Calloway told [REDACTED] that he would dismiss the ticket. PFC Calloway then said, "I keep a little notebook of tickets that I drop for people... Sometimes people hit the Cash App. Sometimes they hit the Venmo. You know what I'm saying? So I go in and drop stuff for people. You know, everybody be happy. If you catch my drift. So Imma, Imma need you to send me bout 400 dollars to this Cash App." Based on these facts revealed during the recorded call and an interview with PFC Calloway, PFC Calloway did violate SC Code of Laws 8-13-705.

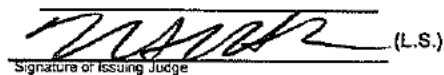
