SLED CHARGES FORMER DIRECT SUPPORT PROFESSIONAL WITH ABUSE OF A VULNERABLE ADULT

The South Carolina Law Enforcement Division (SLED) charged Nadia Aiyanna Humphery, 25, with Abuse of a Vulnerable Adult on Wednesday, August 19, 2026. The Midlands Regional Center requested the SLED investigation. The Midlands Regional Center is operated by the Office of Intellectual and Developmental Disabilities.

Details can be found in the attached warrant.

Humphery was booked into the Alvin S. Glenn Detention Center in Richland County.

The case will be prosecuted by the 5th Circuit Solicitor's Office.

I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:That on or about 06/14/2026 while working as Direct Support Professional for the Midlands Regional Center at 8301 Farrow Rd in
the Upper Township Magistrate District of Richland County it is believed that one Nadia Aiyanna Humphery did commit the crime
of Abuse of a Vulnerable Adult because the defendant did knowingly and willfully abuse the victim, [REDACTED] in the following
manner. Humphery forcefully pushed the victim backwards, causing [REDACTED] to fall on the floor. The victim struck [REDACTED] head on the floor.
The victim was transported to the hospital to receive medical treatment. The victim is a resident of the Midlands Regional Center
and is a vulnerable adult. These allegations were corroborated through interviews, surveillance videos, and information provided to
the South Carolina Law Enforcement Division. All against the law, peace, and dignity of the State of South Carolina.
