SLED CHARGES GREENVILLE COUNTY MAN WITH INSURANCE FRAUD

The South Carolina Law Enforcement Division (SLED) charged Jonathan Martinez-Garcia, 26, with two counts of Forgery – Value \$10,000 or More, and two counts of Making a False Statement or Misrepresentation – 1st Offense on Wednesday, August 19, 2026. The South Carolina Department of Insurance requested the SLED investigation.

Martinez-Garcia was booked into the Greenville County Detention Center.

The case will be prosecuted by the South Carolina Department of Insurance.
